to the said party of the first part, in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, has granted, bargained, sold and conveyed, and by these presents, does grant, bargain, sell, convey and confirm unto the said party of the second part, his heirs and assigns forever, all the following described lot or parcel of land, situate, lying and being in the County of Mesa, and State of Colorado, to wit: Lot numbered Ninety two (92) in Hope Cemetery and

Plot 1, Division A, near

in the Town of Grand Junction, as shown by the Grand Junction Town Company's Original Plat of said Town, on file in the office of the Recorder of the County of Mesa and State of Colorado. said Company - the said

lot being 15 ft long east and west by 20 ft wide north and south and being in the N.W. 1/4 of the S.W. 1/4 of Sec. 10 T.1. S. of R.1. W. of 16 to meridian, the object being to expend said ten dollars on the ground.

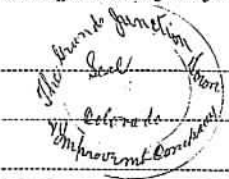

D. 188
