Missouri Library Websites

The Springfield-Greene County Library in Springfield, Missouri, has an extensive digital collection that contains a number of online indexes with information, which may prove useful to individuals researching family in Greene County and the surrounding area. There are several indexes to Greene County Records on this site. They include:

The Register of the Almshouse

Citizens of Greene County, Missouri, who were indigent, as well as those who were poor and ill, were cared for in the Greene County Poor Farm for care. This facility opened in 1875 and became Sunshine Acres in 1955. It closed permanently in 1978. The records in this index have been abstracted from the admission books kept by the superintendents from 1875 to 1855. The entries include name, age, sex, date of admission, date of dismissal, date of death and brief remarks. The entries in the index also include the book and page number of the original record.

Index to Coroner's Record Books

The records included in this index have been abstracted from the coroner's record books for 1875 - 1972. The entries include name and age of the victim, book number, page and date of inquiry.

Chronological Listing and Index to Divorce Records
This database includes abstracts of divorce records in
Greene County, Missouri, from 1837 through 1950. The
entries include the names of the plaintiff and defendant, record book number, page number, date of final decree and
indication of who is the innocent and injured party. The records may also include the circumstance of the divorce, the
amount of support awarded and the names of children.
Index to the Justice of the Peace Docket Books
This is an index to cases brought before justices of the
peace in Green County, Missouri. It covers the period from
1835 through 1885.

Index to Naturalization Records in the Greene County Circuit Court

This is an index to naturalizations filed with the Greene County Circuit Court from 1868 through 1906. Each entry includes the name, country of origin, date of action, type of document being filed (Declaration of Intention or Certificate of Citizenship), and book and page number in the original circuit court record books.

Greene County History

This section of the library website contains transcriptions of histories of Greene County, Missouri. These documents are full-text searchable via the Keyword Search engine. A couple of the histories included here are:

 History and Directory of Springfield and North Springfield This book gives a history of the first fifty years of Springfield, a history of North Springfield, and includes biographical sketches of prominent citizens and a directory of the inhabitants in 1878.

- The Pictorial and Genealogical Record of Greene County, Missouri was compiled in 1893. It consists primarily of biographical profiles of citizens and some business profiles. The biographies found here are not limited to citizens of Greene County.

Black Families of the Ozarks

This section of the Springfield-Greene County Library website contains information about black families in Southwest Missouri and covers the period from the 1820s to the 1950s. The resources here include Slave Documentation in Probate Paper Records of Greene County; Jasper County Slave Records, Slave Hires and Misc. Expenses; Roster of the 1st and 2nd Regiments Colored Infantry of Kansas; and the 1936 and 1937 Negro City and Country Directory, which encompasses both Greene and Jasper counties. Some of these materials may be searched using the Keyword Search engine; others are not searchable via the site's search engine.

Other resources included in the library's Digitized Collections are a collection of photographs and other materials relating to the O'Reilly General (Army) Hospital of Springfield, Missouri, Moser's Directory of Towns, Villages and Hamlets Past and Present of Missouri, and Virtually Missouri, a link to digitized collections for other Missouri areas.

From the "New York Herald" (New York, N.Y.), 21 March 1870, page 8:

STEAM VS. SAILS.

It will be remembered, from the figures heretofore given in these columns, that the whole number of emigrant passengers landed at Castle Garden during the past year was 257,361. Of these 89 per cent, or 229,093, arrived in 444 steamships, and only 11 per cent, or 29,268, in 164 sailing vessels; this gives an average of 513 passengers for each steamship and of but 171 for each sailing vessel.

MORTALITY AT SEA OF EMIGRANTS

As regards this point the great superiority of steam over sails will be evident from the following:-Among 229,093 steerage passengers on steamships there died 210, while 138 died on sailing ships among 29,268 passengers--an enormous disparity of percentage in favor of steam. Of the whole number who died (348) 101 were adults and 247 infants.

Now Online

Google's New Scholarly Search Engine

Google recently launched a new search engine for academic materials. Google officials say the have the cooperation of a broad range of academic publishers, Library groups, scholarly societies, and colleges. The Google Scholar searches the full text of most of the documents it indexes, but some of the results can only be accessed for a fee or with a subscription.

The tool will also point researchers to other works that may be of interest. For the google scholar, go to www.scholar. google.com.

Order NARA Records Online

Researchers can now order NARA records online at www.archives.gov/index.html. Registration is free but a credit card is necessary to pay for copies.

Census pages, immigration, land, Native American, military service and pension records are available. Added databases include Passenger Arrival Records, Eastern Cherokee Applications, and Compiled Military Service Records.

Missouri Military Records

The Soldiers Database, as the collection is called, is searchable by name or unit but could be limited to a specific timeframe or war. Each military record includes the name, rank, conflict, unit, commander, date of service, and where the original record is stored, the researcher by following the link can view and print a digitized copy of the original online. To access the database plus other records visit www.sos.mo.gov. or write to the State Capitol, room 208 Jefferson City, Mo 65101.

Google offers Genealogy Searcher

Designed for use by genealogists the engine is located at www.searchforancestors. com/google/searcher.html. There are several search option, including search for photos, newspapers, and a list of directories.

The search engine is handy for locating a place the engine will search by keyword and location. For instance, a search for "cemetery" and "Logan, Utah," will yield a half dozen primary sites and related sites also. The home page includes tips, suggestions and links, all with the genealogist in mind

Online Civil War Records.

The Civil War Soldiers and Sailors System, a searchable database of those who serve during the Civil War is now online. The site can be access free of charge. Maintained by the Nation Park Service the records taken from the Nation Archives and Records Administration the records allow searches by name unit cemetery or battle. Prisoners and Medal of Honor nominees can also be searched. www.civilwar.nps.gov/cwwss/index.html

Washington State Archives Now Open.

Records available include marriage, birth, death, census, naturalization and military. The website can be accessed at www.secstate.wa. gov then following the "digital archives" link. The historic document collection includes election returns from 1854, the first year as a territory. Searches can be made by name and can be narrowed to specific documentation, such as a birth or death certificate.

There is a fee for a hard copy of the original. Texas Military Records Online

The Texas State Library Located at www.tsl. state.tx.us now includes Adjutant General Service Records and other military files. Texas Rangers and Army of the Republic are among the databases. The site also includes online exhibits.

Arizona Records Online.

The Arizona Department of Health Services features some 400,000 birth and death records. Located at www.genealogy.az.gov birth certificates are made available after 75 years and death certificates after 50 years. The project is a joint effort by the state legislature, Mesa (Ariz) regional Family History Center and the Arizona State Library, Archives and Public Records department.
